Thanking God for Thirumeni's great life and contributions. Thirumeni will be always remembered as a Good Shepherd in the hearts of thousands. Born on 26th April 1944, as the son of Late Sri. C.I. Idicula and Late Smt. Achiyamma of Nedumpram Christos Mar Thoma Parish Chirayilkandathil. C.I. George was called upon to serve the Church as a priest and got the BD Degree from Leonard Theological College, Jabalpur in 1969. He was ordained Deacon on 3rd May 1969 and Kassessa on 14th June 1969. He served thereafter at Palakkad, Olavakkode, Karimba, Nelliyambathy, Attappadi, Kozhinjampara, Kuzhalmannam, Mumbai, Dadar, Toronto, Venmoney Sehion, Kottayam Jerusalem, Madras Chetpet and Edayaranmula Laka St. Thomas Parishes illustriously.

He was selected as Bishop while serving in Edayaranmula Parish. He was consecrated as Ramban on 4th November 1989, and as Episcopa with the name Geevarghese Mar Athanasius on 9th December 1989. He was assigned to be the head of Mumbai – Delhi Diocese. He served as head of Kottayam-Kochi Diocese from 1993 November to September 2001 and from 2001 October continues to head Ranni – Nilackal Diocese. In 2015 October 2nd, Tirumeni was installed as the Suffragan Metropolitan of the Church.

Thirumeni's discourses were the outcome of mature thought, depth of knowledge and wide reading. He was a good friend of Theological books and literary books and periodicals. All his speeches were thought provoking and appealing to all. As a refuge to everyone in distress and sorrow he had a special ability to win the heart of all. He was always able to pass on to his audience the depth of Biblical thoughts in a natural and poetical style. His mature and creative leadership has always provided new avenues as for service as a shepherd. Thirumeni will be always remembered as a Good Shepherd in the hearts of thousands.

Permanent arrangement for the projection of Worship service in the stilt area enabled the worshipers there to more meaningfully partake in the worship service. Mr. Yayabhai Ebrahim Dhariwala donated a plot of land admeasuring 35 Aar in Gut No.46, and 33 Aar in Gut No.49 situated at Giravale Village, Panvel Taluka for this purpose to be named as "E.V. Dhariwala Senior Citizens Retirement Home".

We have finalized the lay out and submitted all required documents to MSRDC for approval through the liaisoning Architect M/s. A.N. ARCH. Project conveners Mr. Binu Pappachan &

Mr. T.S. Thomas taking their earnest efforts in follow up along with the office bearers to receive the approvals as early as possible.

Finance committee met few times and discussed the options to raise the fund for the construction and their suggestions are presented in the Joint meeting of project committee and Managing Committee. These suggestions will be considered in the new financial year for implementation.

B. TREE & VEGETABLE PLANTATIONS AT PROJECT SITE

We had planted more than 110 saplings on 5th February 2017 along the boundary and cultivated vegetables at our project site till the building come up. All those trees and plants are grown now and our site has become a beautiful Garden with different plants and vegetables. During the year we have harvested plenty of Tomatoes, Bananas, Brinjal and other vegetables and the same are sold / auctioned to our members on Sundays, after the worship service.

We extend our sincere thanks to Mr. C.J. Joseph for his whole hearted effort, which keeps the plantations alive and fruitful. Also thank Mr. C.M. Thomas and Mr. Thomas Abraham for extending their support. Mr. Sainath & Mrs. Asmitha, our care takers at Panvel are hard workers and their continuous efforts are helping the plants for even growth.

C. CEMETERY

As a part of maintenance activities of the cemetery, we have obtained water and electricity connections and deployed security guards round a clock.

We express our sincere thanks to NMMC for the financial Support to maintain the cemetery. Also extend our gratitude to Mr. Sabu Daniel for helping to avail this support. Mr. Sabu is representing our Church in the Nerul and CBD cemetery trusts.

We have paid membership fee in Nerul & CBD Cemetery trusts and our members residing at CBD area also extended their contributions for the development of the burial ground allotted to us at CBD Belapur by NMMC.

D. UNIT AT PUNIT INDUSTRIAL PREMISES, TURBHE

The 400 square feet unit, which we purchased in 2004, was given on Caretaker agreement for a nominal charge. This amount was utilized for Mission and Charity activities jointly by the Parish and Sevika Sangham. This unit is an asset of our Parish.

18. DIOCESAN / NAVI MUMBAI CENTRE RELATIONSHIP

Our Parish and Mumbai Diocesan office in the Mar Thoma Centre maintained an excellent relationship. We continued to support various activities of Mumbai Diocese. Our member and Diocesan council member Mr. Sabu Daniel was the General Convener for the Convention arrangements and few of our members were worked as committee members in

various sub committees formed for the smooth conducting of this function. Our Vicar, Rev. Gigy Thomas and members of our parish were at the front line to coordinate all the programmes and extended all the support especially for arranging the Madbaha at CIDCO Hall.

Some of our members opened their houses to accommodate the guests who had come to attend the convention from faraway places.

We were privileged to have the worships and meetings of the Diocese and Navi Mumbai Centre at our Church.

1. Prayers

Prayer is the source of power behind every ministry. We have monthly Edavaka Mission Prayer meetings at the homes of our members on the 1st Wednesdays of every month. The third Sunday of every month is earmarked for holding a Dhyanayogam along with the Sunday worship service. A speaker from outside is invited to speak during the Dhyanayogam according to the slot available. As part of this initiative, during the year on Sunday 15th October, we were fortunate to have Bro. George Cherian, General Secretary of Missions India sharing from the word. The Prayer Chain; an initiative by the Edavaka Mission, which consists of a group of members who daily pray for the needs of the Church members. The prayer requests are posted on a Whatsapp Group created for this. As on today there are about 80 plus members who are active in this group. We have also had our Prayer Cell to cater to the specific prayer needs of families and members in our parish. The Prayer Cell is committed to intercede with God for the various prayer points relating to the Church, our society, nation and the world at large. Prayer Cell meetings are held every week at homes of the members who have special prayer needs/requests or at the Church.

2. Fasting Prayer

Fasting prayer is held at the church, every Friday, at 10:30 am. To be a spiritually growing church we need praying members. We appeal to all members to join the fasting prayer and make our church a spiritually vibrant church.

3. Prayer Partner Initiative

This is a newly initiated program since 2015 under the co-ordination of the Edavaka Mission by which each family in the parish is assigned another family at random and they are encouraged to pray for the assigned family. This initiative has helped in bringing the families closer and in inculcating a habit of praying for others. During the year, on 16th July 2017 there was a prayer partner meet in which the praying families met each other and shared

their experiences and gifts. Mr. Anil Mathews and Mr. Saji Mathew were the conveners of this program during the year.

4. Mission Week

The 1st Sunday of October was celebrated as the Mission Sunday followed by Mission Week celebrations. A Special Prayer Service was held during the worship which was led by Committee members of the Edavaka Mission. Members of the Edavaka Mission Committee also assisted in the worship service. As part of the exchange program, Mr. Manoj Thomas from St. Thomas MTC Kharghar visited our Church on 01st October Sunday and Mr. Reji Sam from our Parish visited St. Peter's Church, Panvel on the same day.

Edavaka Mission Members as groups also visited homes of the elderly and sick members of parish during this week.

5. BP Check Desk

The BP Check desk introduced for the benefit of the Church Members continues. Our Edavaka Mission Members Mrs. Sarah Wilson and Mrs. Annie Joseph; who are Certified Nurses, manage this desk and assist the members who want to monitor their BP on a regular basis.

6. Dhyanayogam

A Dhyanayogam was organized at the Church on 13th Friday October 2017, which was led by the Navajeevodayam Missions India Team. Apart from our own members, believers from neighboring parishes and congregations of other denominations also attended this meeting. Rs. 25,000/- was collected and handed over to Missions India as part of supporting their ministry.

7. Mission field visit & support

Edavaka Mission took the initiative in organizing the visit of a team of 11 members of the parish, including Vicar Rev. Gigy Thomas and Susan Kochamma, to our parish Mission field located at Shengaon in Vidarbha region on 16th and 17th of September 2017. Shengaon Mission field comprise of about 14 villages. Evng. Santosh Latilwar and his wife Stella are doing an excellent work here spreading the gospel and expanding the ministry. As decided by the Church Committee; especially being the Silver Jubilee year of the ordination of Rev. Gigy Thomas, the foundation stone for the construction of a Church in Shengaon was laid during this visit. God willing, our effort is to complete construction of this church within one year. During our visit: Rev. Roy Thomas, Vidarbha Region Missionary Achen and Bro. Pradeep David, Mission Co-ordinator, Vidarbha Region accompanied us.

Apart from the above; as in the earlier years, our Edavaka Mission has also contributed Rs.23,000/- towards Mission Support to the MTVEA, Navi Mumbai Centre. This amount is utilized towards the support of the Evangelist in Shahpur Mission Field in the Vidarbha Region.

8. Distribution of Daily Bread

As in the earlier years, this year 140 copies of Daily Bread were procured and distributed to the members of the parish both in English, Hindi and Malayalam.

9. Whole Night Prayer

A Whole Night Prayer was observed on 25th January 2018. Rev. Gigy Thomas Vicar, Bro. Mathew Enos, Panvel Parish & Evangelist Kurian Thomas, Panvel led the meditation sessions. FUND RAISING PROGRAM:

A Fund Raising Football Tournament "Cup of Life - Season 3" was organized by the youths on 2nd September, 2017 for the Save a Heart Project. The tournament saw a participation of 22 teams from Mumbai Diocese. 3 Teams from our won church participated among whom 1 of the team were the younger generation kids (less than 18 years). The team led by Mr. Sanu Daniel won the tournament and the team from Pune Khadki came Second. The event was a grand success. The Sakhyam extends its sincere thanks to the parents of all the youth members and all the parish members who contributed in making the event a grand success. An amount of Rs. 134,300 was raised through registration and donations.

Carnival

We also had carnival as part of youth fund raising. It was conducted on Family Sunday i.e. October 4th Sunday. Youths had organized food sale, games, sale of jewellery, etc to generate fund for our Yuvajana Sakhyam. Overall it was a successful event, with the key attraction being tug of war, where not only boys, even girls and aunties participated in the

event and enjoyed. An amount of Rs. 77,800 was raised through sale of food items, games and jewellery.

ONAM CELEBRATION:

The onam celebration was held on 24th September, 2017 at St Pauls Mar Thomas Church Vashi from 5 pm onwards. Our Diocesan Bishop Rt. Rev. Dr. Geevarghese Mar Theodosius Episcopa was the chief guest. This year's onam was solely arranged by the youths. There was a small skit by the Sevika Sangam members on the history behind the onam celebration. Mr George. M. SAVE A HEART SAVE A CHILD
